Exhibitor set-up will take place on Saturday, October 21 from 6am- 9am. **No exhibit will be dismantled in any way prior to closing time.** All exhibits must have an attendant during show hours Saturday, October 21 from 10am – 2pm. All displays must be contained within exhibit space.

EXHIBITOR'S signing this agreement shall not sublet any part of the space without prior written approval of show management. Use of Public address systems and other sound amplification must have prior approval of Show Management. Show Management reserves the right to refuse any applicant for space deemed inappropriate. Exhibit Space cancellation notice submitted by October 10, 2017 would receive a full refund. Cancellation notice submitted between October 11 and October 18, 2017 will be entitled to 50% refund. Cancellations received on or after October 19 receive no refund and said booth space will revert back to Show Management.

Liability and Lawful Operations: **Rods & Wheels Cruise-In at Ditto Landing** and Ditto Landing will assume no responsibility for damaged, lost or stolen property. Insurance on the EXHIBITOR'S property is the responsibility of the EXHIBITOR. Electricity and use of flammable materials must conform to all local regulations. Firearms and other weaponry are not allowed without special permission from Show Management. EXHIBITOR shall comply with all federal, state and municipal laws and administrative rules, including but not limited to those relating to license and permits, ordinances and regulations applicable to the exhibit.

Indemnification: Any damage to premises is the responsibility of the EXHIBITOR causing the damage. Any restitution for such damage remains EXHIBITOR'S responsibility. EXHIBITOR agrees to hold **Rods & Wheels Cruise-In at Ditto Landing** and Ditto Landing harmless of any liability, injury or damage to person or property that may arise out of the use of the premises by the EXHIBITOR pursuant to this agreement. EXHIBITOR agrees to hold harmless and indemnify **Rods & Wheels Cruise-In at Ditto Landing** and Ditto Landing against all actions, liabilities, damages, losses, expenses, debts, taxes, fees, charges, assessments and other claims which may be caused by, arise out of, or are in any way associated with or contributed to directly or indirectly, by any act, omission, negligence, fault, or violation of any law or regulation by the EXHIBITOR or any of the EXHIBITOR'S officers, employees, agents, independent contractors, volunteers, guest, or visitors including but not limited to the costs of investigating, processing, litigating, or settling any such claim and **Rods & Wheels Cruise-In at Ditto Landing** and Ditto Landing reasonable attorney fees.
